SECTION-II

PROCEDURE FOR E-TENDERING

- 1. The Bids shall be received electronically only through the website **etenders.hry.nic.in**
- **2.** Bid Document can be downloaded from the website of http://etenders.hry.nic.in or haryanatourism.gov.in
- 3. The Bidders shall have to submit their Bids (Technical Bid & Financial Bid) online in Electronic Format with Digital Signatures. For participation in the e-tendering process, the Bidders need to register themselves on http://etenders.hry.nic.in. On registration they will be provided with a User ID and a system generated password enabling them to submit their Bids online using Digital System Certificate (DSC).
- 4. The Bids shall be uploaded in Electronic Format on the website http://etenders.hry.nic.in.
 Scanned copies of Earnest Money Deposit, Document and Eligibility Documents shall also be uploaded alongwith with Technical Bid within prescribed time limit.
- 5. Processing Fees, Tender fees & EMD will be submitted online

SECTION-I

ELIGIBILITY CRITERIA FOR Bidder

The bidder must possess the requisite experience, strength and capability in providing the services necessary to meet the requirements as described in the tender documents. The bidder must also possess the technical know-how and the financial wherewithal that would be required to successfully provide the services including prior and post also as per requirement.

The invitation to this Tender is open to all bidders who qualify the eligibility criteria as given below:

1. The Bidder should be a single business entity (the "Single Business Entity"). The term bidder used herein would apply to a Single Business Entity.

A Single Business Entity shall mean a company incorporated under Companies Act, 1956/2013 or a Sole Proprietorship firm registered under Proprietorship Act, 1908 or a partnership firm registered under the Indian Partnership Act, 1932 or a Limited Liability Partnership firm registered under Limited Liability Partnership Act, 2008.

Note:

- a) Consortium or Joint Venture is not allowed to participate in the bidding process.
- b) If the bidder is:
 - i) A Company should furnish copy of the certificate of incorporation and memorandum of association as a proof of identity.
 - ii) A sole proprietorship firm, and a limited liability partnership firm should furnish copy of the registration certificate, GST and IT return for the last three financial years preceding the bid due date as a proof of identity.
 - iii) A registered partnership firm, it should furnish a copy of the IT returns for the last three financial years preceding the bid due date copy of the registration certificate under the registrar of firms and a copy of the partnership deed executed between the partners as a proof of identity.
- 2. A Bidder is required to fulfil the criteria specified below. Any bidder who does not meet the criteria set out below shall be disqualified.
 - (a) The Bidder must have an average Annual Turnover as mentioned in "Eligibility Criteria for Minimum Turnover and Work done" in the last three financial year i.e. 2022-23, 2023-24 & 2024-25.  - (b) Balance Sheet for the year 2022-23, 2023-24 & 2024-25 duly certified by Chartered Accountant.
 - (c) Experience of working in Event/Mela/Fair/ Seminars/ Conferences/ Exhibitions, Forums/ Conclaves/ or any combination of the same related to fields of Infrastructure Sector/ Tourism/Crafts or any other similar field for a State Government/Central Government/ National apex chamber/PSU's or any Government of India event Inside/outside India having successfully completed similar work during last 3 years upto 2024-25 should be either of the following: -



- a) Three similar completed works more than or equal to amount as mentioned in "Eligibility Criteria for Minimum Turnover and Work done" Or

The Bidder should not have been blacklisted by any Government/ Semi-Government Department or PSU/ Institution / corporation / federation and not connected to any firm who has been so blacklisted in the past five years. Online e-tenders are invited from reputed hotels, resorts, or hospitality service providers for providing Boarding and Lodging services for approximately 500 Teachers during an educational program from 02.01.2026 to 14.01.2026 in/around Nainital. (Uttarakhand) and surrounding areas.

1.The service provider shall be responsible for providing comfortable accommodation and full catering (Breakfast and Dinner) for three consecutive batches.

The earnest money shall be refundable to the unsuccessful bidder. The earnest money shall, however, stand forfeited in case the bidder with draws his offer after opening of the bid but prior to the final allotment.

- 3. GST will be paid as per the BOQ. If, there is any changes in GST the same will be paid accordingly on submission of the document.
- 4. E-bids are to be signed by the person(s) who are competent and lawfully authorized to do so. Correction/overwriting, if any, should be authenticated under the signature of the bidder/authorized signatory.
